## Kennet & Avon Canal Bicentenary Calendar Photographic Competition Rules

1. Only photos taken in landscape format will be considered.
2. Only photos taken on the Kennet & Avon Canal during the month stated will be considered.
3. Photos should be entered as either a) a professionally produced print, no smaller than 6" x 4" or b) a digital image in a JPG format at no less than 300dpi.
4. Only one photograph per entrant per month can be considered.
5. The photographic image must not be subject to any manipulation. The competition Promoters reserve the right to exclude any image they believe may have been treated so as to alter its authenticity.
6. Entrants must not be professional photographers.
7. The employees and families of the Promoters are not eligible to enter the competition.
8. Each entry must be accompanied by a completed entry form.
9. No entry can be returned and proof of posting is not proof of receipt. The Promoters accept no responsibility for entries lost, damaged or delayed in the post.
10. The judges' decision will be final and no correspondence can be entered into.
11. All entries must be original work and must not have been previously published. The entrants must be the sole owner of copyright in all photos entered and must have obtained permission of any people featured in the entries.
12. By entering the competition entrants grant the right for the Promoters to publish and exhibit their photographs in any media and/or format they think fit including but not limited to commercial uses. No fee will be payable for this use. By entering the competition entrants waive their moral rights in respect of the images submitted.
13. Finalists may be asked to take part in post competition publicity.
14. The promoters reserve the right to substitute an image of their choosing in the event that no suitable entries are submitted in any month.
15. By entering, entrants will be deemed to have agreed to be bound by these rules.
